

When reason fails to guide us in our everyday lives, we turn to faith, to religion; we close our minds; we reject austere reasoning. This rejection, which is a faith-based social and intellectual malignancy, has two unfortunate consequences: it blocks the way to knowledge that might enhance the quality of life and it opens the way to charlatans who exploit the faith of others. Examining two unquestionable malignancies of "the Christian Right" in present-day politics in the United States and the "secular religion" of Hitler's National Socialism, as well as the third, more complex case of Gandhi, the author asserts that we need religion, but we also need to make sure it does no harm.

F.G. Bailey is Emeritus Professor of Anthropology at the University of California, San Diego, where he taught from 1972-1994. He was formerly the Founding Professor of Anthropology at the University of Sussex, UK and published 15 books (two of them edited volumes).

Gary B. Cohen, has been director of the Center for Austrian Studies and professor of history at the University of Minnesota, Twin Cities, since 2001.





In 1944, Raphael Lemkin coined the term “genocide” to describe a foreign occupation that destroyed or permanently crippled a subject population. He then wrote an unpublished book manuscript than analyzed instances of genocide in world history, most of them in imperial and colonial contexts. This volume follows in Lemkin’s footsteps by embedding genocide in the epochal geopolitical transformations of the past 500 years: the European colonization of the globe, the rise and fall of the continental land empires, violent decolonization, and the formation of nation-states. It thereby challenges the customary focus on 20th century mass crimes as well as showing that genocide and “ethnic cleansing” have been intrinsic to imperial expansion. Based on archival research, this volume is a world history of genocide that highlights what Lemkin called “the role of the human group and its tribulations.”
